A practical interface for lightsticks is just behind the high pockets on the arms. 2 axillary zips are available to emphasize transpiration and sweat evacuation in case of body overheating. Loop stretch patches are present on the high arms pockets to stick ID / IFF patches. Cordura protection on the elbow with removable soft antishock padding. This is an absolutely essential item for operations in cold and wet environments.
