Recent Updates made to B3 Duffel

- Drag handle moved lower on duffel to improve comfort when rolling.
- Drag handle access port in rain cover removed to improve moisture protection.
- Loop backing added to internal Molle webbing to improve security of internal partition panels.

Modular hook and loop panels allow you to partition off various sized compartments to divide gear or clothing.
