The last-generation elasticated fabric and ergonomic model offer unmatched comfort and an exceptional resistance to wear. Thanks to the nanotechnology used for its production, the fabric of these pants maintains a constant temperature even when exposed to direct sunlight. The pockets have been designed to guarantee access even when wearing harness. There are 2 small pockets for small multitools or cord-cutting tools.

Provided with two air inlets on the sides and with an opening at the bottom of the legs regulated by a YKK zip and pull.

The patches on the knees are made of Cordura 500 and contain soft extractable protections. All the parts most subject to wear are reinforced with Cordura. The bottom part of the inner leg is reinforced by a patch made of Cordura.
